#### Common Themes:

The following 7 topics emerged as common ground. These include issues participants feel are critical for this group to consider and recommendations for necessary actions to ensure success.

### Respect Varied Perspectives

Balancing conservation and recreation is hard with few obvious solutions that please everyone, but it's critical to hear divergent perspectives so we can have a holistic view in mind. We should engage individuals who listen to others and don't target or denigrate any particular user group, as everyone's actions have an impact, and we all share a love for this region.

# OZ Act Collaboratively

There are many organizations doing great work that should be given space to focus on their core issues. This RPI, rather, can assist with coordinating resources more effectively across interests and municipalities to take collective, collaborative action rather than a piecemeal approach.

# 03 Seek Representation & Inclusion

It is important that the unique needs of all counties are equally considered, that this initiative is non-partisan in nature, and that those involved actively seek out input from community members who aren't always included in conversations on recreation and conservation, such as those in the agriculture community or community members who engage with the outdoors more locally.

#### O4 Focus on Education

Participants share a desire for educating policymakers, local community members, and tourists on issues, such as the need for seasonal closures to protect wildlife, and principles, such as Leave No Trace, and Stay the Trail. Encouraging membership in established groups teaching responsible use, developing compelling messaging and outreach methods, and recognizing the impact of social media on improper use will be key.

# 05 Identify Funding

Participants recognize that so much trail maintenance and conservation work relies on volunteer efforts, so they underline the importance of securing a funding source to support this initiative and its projects which are critical to preserving this region and supporting an intentional future.

#### 🕛 🖟 Pursue Quick Results

While planning and discernment is key to success, there is a shared desire for moving quickly to identify common ground among those representing different interests and counties, and to make fast progress on some quick win projects to build trust and momentum.

### Establish Consistent Communication

It was noted that effective communication across communities, user groups, and government agencies is not the norm, but will be essential to ensure everyone is on the same page and agreements can be reached.

# **Key Considerations:**

We are building our steering committee and preparing a grant application to secure resources that will support initial actions. We are keeping these considerations in mind as we move forward:
